# **New York State Graduation Requirements**

### Understanding Exemptions due to the COVID-19 Public Health Emergency

During the COVID-19 public health emergency, the Board of Regents' approved exemptions to the requirements for students to earn a New York State high school diploma.

Students granted an exemption are not required to pass such specific exam(s) to meet the assessment requirements for any diploma type (local, Regents, or Regents with advanced designation). Exemptions remain with students through their graduation or through exiting high school.

## **Exemptions due to COVID-19**

Students who met one of the following conditions were eligible for exemption from the diploma requirement of passing a Regents Exam:

#### Parental Right to Decline Exemptions

Parents and persons in parental relation of students who are eligible to graduate as a result of having met an assessment requirement through an exemption due to COVID-19 may decline such exemption.

If a parent declines an exemption, it's important to remember:

### Seals & Endorsements

Students can still earn all diploma types, seals, and endorsements.
